- You may be placed on either a monthly or quarterly billing frequency. Confirmation of the frequency will be set out in your contract
- A payment processing fee of 1% (GST inclusive) may be applied if you pay your bill by credit or debit card
- We will provide you with an Electronic bill (eBill). However if you would prefer to receive a paper bill a charge of \$2 GST inclusive (per bill) will be applied to your account
- Other fees and charges may apply from time to time for services outside of the supply of electricity. A list of these fees and charges is made available on our website
